Dear Mr. District Attorney Brazelton:

I am writing to request to be called by you and/or your office to the Stanislaus County Superior Court to testify and provide evidence to the Court and the American people about Laci Peterson's double murder case. I have reliable evidence to show the state and the public that Scott Peterson did not commit these double murders of killing his wife and their unborn son, Conner.

I will prove to you, the Court and the American people that it was my former employer the California Department of Corrections (CDC) committed these two gruesome murders with the assistance from the Federal Bureau of Investigation (FBI). They kidnapped and murdered Laci Peterson randomly on December 24, 2002. Yes, I am certain that [REDACTED] and don't forget his wife is involved, is responsible for the killing. This is extremely horrible, so brace yourself. I won't hold it against you if at first you go in denial about it.

I have stated that I was at their townhouse in London while they waited for a phone call and had an argument, finally deciding to load the body into the trunk of his car. I was standing there in shock, etc.

They truly ENJOY their torture, you must try to comprehend. When I was debriefed by the Director, he had already contacted a CIA shrink, who put forth his analysis of it all. There is some kind of "Ultimate" power trip and sexual gratification in cutting off a sexual part of a helpless victim, and even if Police came that minute, their sexuality was forever gone, to them, I was told, for example.

They knew I couldn't leave, and started enjoying telling me things for the horror of it all, which they drank in like wine or something. [REDACTED] was pretty stoked about the fact that they now had the "Career" they wanted, because he figured he now had the protection of the 2nd most powerful man in the world, the Dir. Of CIA Ops. The blackmail angle meant he could accumulate all the political power he wanted, and he did eventually get put into Congress through this means, infiltrating an Intel. Committee, even.

So she told him to tell me what his "Ultimate Thrill" would be, just before they "Retired." He said that it would be to either castrate or behead a baby before its mother's eyes, I can't remember which it was. But that he also sort of wanted to cut that baby right out of the mother's body, first, or something to that effect. I honestly don't want to remember the details.

Why do you keep ignoring the fact that Laci Peterson was in Oregon as well as in Washington? I know she was here because, as I have repeatedly told you, I visited with her for about 45 minutes. Scott could not have killed her. Laci said she could never go back to Modesto. You have all the rest of our conversation--at least I did send it to you.

Why has nothing further been said about the man who confessed to killing her in Oregon? It is likely she was murdered in Oregon and then her body was dumped in the Bay as that man claimed. How many days did the police drag the Bay, looking for her body, with no results? Later, then, the baby's body surfaced.

Mark Geragos is right. He probably did not call me to testify because my conversation with her cannot be verified by a witness as we were the only two people sitting on that seat set on the train, and people on the train at 6:00 a.m. on a very cold day were not exactly interested in anyone else's conversation.

I am not finished with this investigation and shall pursue it on my own up here. There are many cults in the area and Laci said she had been with a man in a cult.

Like the rest of the media, your newspaper disregarded the information on Laci's whereabouts after Scott is alleged to have murdered her. She was in Portland, Oregon--by herself--and had admittedly been in the company of a man "in a bad cult, in the hills behind us," referring to the hills West of Portland.

A man from Oregon confessed to killing her, but the Modesto police disregarded his confession because "he was crazy." Wouldn't it take a crazy person to commit that crime?

Why did the Modesto police have jurisdiction over her disappearance? The FBI usually handles kidnappings, and there is good reason to believe she was kidnapped.

Hype from the Press convicted Scott--not evidence. A crazed and angry crowd displayed their anger within sight of the jury, and the judge did nothing.

Scott was guilty of cheating on his wife. From a woman's standpoint, I can see jailing cheating husbands, but I cannot see punishing them by convicting them of a crime they could not have committed.

The other "crime" here is the ignorance of the truth that she was here in Oregon by herself right after her last visit with her doctor. How do I know that's right? She told me she was not going to return to Modesto--her husband was in love with another woman. She told me she did not need to return because she had just seen her doctor for her final visit before the child was expected and "everything is fine."

She told me she had been in the West Hills of Portland with a man "in a cult", which she described as a "bad" cult. She did not further describe the nature of that relationship, but said she could not return home. Surprisingly, she said she definitely could not ever go back to see her mother or sister--but gave no further explanation.

This information has been totally ignored--discounted--and I cannot understand why. It is a sad world when the press sells out to the hype of the crowd.

RE: The Anthrax Attacks, DC Sniper Shootings and the Laci Peterson's Murder

Dear Mr. President Bush:

I am a Chinese American citizen and a former California Correctional Officer. I am writing to request you to inform Attorney General John Ashcroft and California State Attorney General Bill Lockyer that I request to be subpoenaed to San Mateo County Superior Court Judge Alfred Delucchi's Courtroom to testify on Laci Peterson's murder case because I have concrete and crucial evidence to prove to the court and the American people that Laci Peterson and her unborn son Conner were not murdered by her husband Scott Peterson. I can prove that Laci Peterson was abducted and murdered by my former employer the California Department of Corrections "CDC" and the California Highway Patrol ("CHP") with the assistance from the Federal Bureau of Investigation ("FBI"). I also can prove that Laci Peterson's murder was related to FBI's Anthrax plot in September of 2001 and FBI's DC sniper shootings plot in October of 2002. The Anthrax attacks were used to curtail my mails to the media and Congress, which reported FBI and CDC's crime; the DC sniper shootings was used to warn me not to expose FBI and former Governor Gray Davis' Anthrax plot to the public before 2002 mid-term election. The alleged snipers John Muhammad and Lee Malvo were innocent. The real DC snipers were a group of CDC and CHP employees that traveled to DC area and the FBI assisted them to shoot and kill innocent citizens. On 12-23-2002, the CDC, CHP and FBI intercepted a letter from me, which was addressed to Mr. Bill Miller, a Washington Post reporter. This letter discussed FBI and CDC's Anthrax and DC sniper conspiracy. On 12-24-2002, they abducted and murdered a Modesto pregnant woman Laci Peterson to send a death threat to me that if I expose their Anthrax and sniper plot to the public they will abduct and murder my daughter. They abducted pregnant Laci Peterson was to demonstrate their cruelty and serious intention to me. They chose to abduct and murder Laci in Modesto because it has to do with another Modesto woman Chandra Levy's murder. I will prove to the court with all pertinent evidence in this matter. In the past, I have informed you and Governor Schwarzenegger several times of this situation, but I have not received any responses from either of you. I also have informed and requested Stanislaus County District Attorney James Brazelton and Scott Peterson's lawyer Mark Geragos to subpoena me to testify on Laci Peterson's case, but my constitutional rights have been denied and deprived. The FBI, CDC, CHP and local law enforcement agencies not only have continued kidnapping and murdering innocent citizens to threaten my daughter and me, but also abusing their power to frame innocent citizens with those crimes. Dear Mr. President, You invaded Iraq and toppled Saddam Hussein's regime. You want to rebuild a democratic Iraq and try Saddam's crime in the public. But how can you make a safer America and also spread democracy in the Middle East while your White house is involving in terrorist act including poisoning, sniper shooting, kidnapping and murdering against innocent citizens to cover-up the crime? And how can you convince the world that Saddam will receive a fair trial in Iraq under the U.S. occupation while my legal rights have been denied to testify in a court of law on a serious murder case which related to your White House's corruption? Now, I am requesting you to inform Mr. John Ashcroft, Mr. Bill Lockyer and Judge Alfred Delucchi about my request. I am also requesting you to respond to my family that why do you still allow your administration and local law enforcement agencies to kidnap and murder innocent citizens as death threats against my family and other innocent people. The American people have the right to know the truth. Due to the government's ongoing interception of my correspondence, I will also send and fax this letter to public officials, private organizations, the media and the U.N. Security Council and ask them to forward this letter to you. I await your response.

There could be a Satanic Link of some occult members having once lived in Corona Alabama having moved to California following the fire at my grandmothers first home which they had bought but I do not know whom they are nor what they look like but if you need info about them you might have to go to The Daily Mountain Eagle in Jasper Alabama (the newspaper) because Corona is such a small town that it lost its Official Post Office due to having to few residents and theres no Police Force nor City Hall whatsoever, therefore the only info might be only obtainable from the county seat which in in Jasper pertaining to the property they had bought. My Step-Grandfather told me about the purchasers once as we drove past and related that maybe they might be involved in drug trafficking in the county. My Step-grandfather passed away in 1986 so this was sometime ago that they moved prior to his funeral. But even so if Scott tells a story of satanic criminal possibilities in the case he could have had a friend that tricked him to believe a satanic cult existed and thereby told Scott that to be initiated into the cult he would have to prove his faith in it thus fearing more the friend than the police from his friends stalking him during outings to see Amber Frey and once to find money in the trunk of his vehicle possibly placed there by the same friend that helped him do the tree removal in the yard and laying of red bricks with mortar at the house was showing Scott he did have keys to everything including Laci's vehicle and the home, so Scott could have decided to flee that area, but also that the friend could be another victum of Scott having been killed either prior to leaving or during the time Scott vanished to end up at his parents home. I suspect a friend would have kidnapped Laci according to instructions from Scott the morning she walked the dog and had told Laci he was going to get gasoline as a excuse for leaving that early and did not at that time but met the friend. Laci might not have ever met the friend and then to Laci would have had to be placed into the boat following Scott getting gasoline prior to heading to the launch area as he could not have done that by himself and would have had to remove the body had he did it himself. The friend seems to me to be hap hazard and skeptical of Scott, but might have desired attaining a computer and learning about computers from Scott. I would believe that if a foreign group were responsible for the crime to Laci that foreign group would have disclosed at sometime to authorities they claimed responsibility and there has not been anything such as that occurring. Satanists wouldn't have accomplished the crime without having been detected and perhaps would not have had a boat at all and more unlikely have a airplane or helicopter to dispose of the body in San Francisco Bay. To find a boat associated with Satanists or occult groups in or near San Francisco might have some repercussions but like I said the friend could have actually been the murderer of all other victims and not a occult and no one has connected the dots with them stacks of tree stumps and bricks to a friend yet. If a friend is ever found it might be difficult to pin down that the friend has a connection to someone with a boat or own a boat himself which is in ill repair, but keep your thoughts on that a friend existed and is perhaps dead. Satanist Occult stuff is not to difficult to acquire, its sold in stores and perhaps even was a collectable and if Scott has none at his home he perhaps removed whatever he had to place at the friends final resting place to curb the police that Satanist and occults were behind the crime instead of he having the only boat. Scott could have eventually determined the friend lied to him about Satanist and occult connections making such a decisive move to lure authorities away from him. I do not trust Scott and I feel no one should even if theres some Satanist in San Francisco that could commit crimes against humanity which is more unlikely than to cleanly suggest that there are crimes being committed and yet have no evidence to show for them. The report of the condition of the body seems to be to be somewhat a decisive matter to lure away any accidental death that might occur if perhaps a deep-sea fishing line had been tied around the head and onto a bag of cement then placed in the back of a pickup or other truck and accidentally the dried-up cement fell out and

I read your story on whether or not Laci's death was cult related. You're right, it isn't cult related, it's occult related and there is a big difference between the two. I am a survivor of a politically powerful occult. I spent my life in training for a war, from the ages of 1-10 I was give occult training, from the ages of 10-13 I was given cult training, from the ages of 13-16 I was given government secrets, from the ages of 16-19 I was give training in the politics of business. I then was in three arranged occult relationships that lasted 6 years each. 9years, 3years, 3years,3years, 6years, 6years, 6years and the final 3 nine years have not come yet. The occult is far more intelligent and advanced than anyone gives them credit for and that is how they will get away with their plan. YOU, the society, will allow it! Everyone has a price, fear, greed, jealousy, pride...everyone has their weakness. If you aren't willing to risk it all to get the truth out, then you will become yet another puppet for this game.

I think with all the training I have been given first hand, that makes ME an expert on the occult and even the cult. But, I'm not credible am I?

CLUES THAT PROVE LACI'S DEATH WAS OCCULT RELATED

First a background to occult and cults. There is a significant difference between the two. An occult is the worship of Satan and its purpose is to start a Satanic war in this country. Its members are not deceived about who they serve or worship as opposed to the cult, whose members are under the pretence of serving the God of heaven but are really serving Satan. Both are influenced by power and control of their members and both have extensive knowledge of the bible, but not because they have actually read it. Neither groups are permitted or encouraged to seek information on their own, they are forced or coerced into seeking only wisdom from their leaders. Occults perform sacrifices of every kind including humans, and cults perform sacrifices of animals. The end result for occult members is to prepare and train them for war and the end result for cult members is to weed out the believers and worshipers of God in heaven and destroy them completely either by loss of their mind or by loss of their life through the occult so that the rest of the members do not suspect that the cults are doing it. Or in masses like Jones town, where it instills fear and paranoia in the public towards religion and God. It gives a strong impression that God is not able to save those who seek him. For both the occult and cult the only bible they are permitted to possess or read from is the King James Version. Again they are not encouraged to read it on their own and they are under such powerful influence of the group that they dare not question its leader. King James had a background in witchcraft and possibly masonry practices and that is why that is the only version they are permitted to read.

Saying that Laci's death was not cult related is true, it was not a cult who did this. But it was an occult ritual. The media is getting away with deceiving the public on this one because of the use of words from the attorneys. They can absolutely be proven truthful by saying it wasn't a cult. But if the pressure were on the occult, it would be a different story because there is too much evidence to back up that it was occult related.

I've been reading many different articles on this case and it's hard to keep track of them all so I'm just going to give the information I've seen and it's up to you to investigate, but really dig for answers because members are going to do their best to shut you down at every turn.

- 1) Check Judges 19 in the bible. It refers to a woman being cut up and her body parts sent to tribes as a call to war. Only in this case, Laci's body parts would be sent to different organizations or secret societies, undoubtedly the police or Fraternal Order of Police, (Fraternal, referring to male, so although this organization has a perception of being for good, the under tone of it is that it is a secret, male society.) and there is a group within the police dept. that not many know about called dog or god spelled backwards because they believe they are gods from the Egyptian deities.
- 2) Check out the Fraternal Order of Rosicrucians in San Jose, CA and learn about the Egyptian, Oriental, and Mexican (Aztec) burial practices. You will find that they take out all of the internal organs except the heart to prepare the body for burial. In some occult practices, the heart is eaten for power but if the occult was practicing an Egyptian ritual it would have been left behind.
- 3) I read somewhere that Laci's 9th rib on the left side was broken and her 5th and 6th ribs on the right side were broken. Occults practice numerology, not cults. Cults forbid such practices. If you put that down on paper it would look like this 5+6=11/9 reverse it and you get 9/11. Occults practice mirroring and upside down and backwards codes for their messages and plans to other occult members. It's like the pieces to a puzzle, not every one has the same piece. Also, this practice is found in Egyptian Hieroglyphics.
- 4) 8 is a number symbolic for Satan, not 6 like everyone thinks. 6 is symbolic for man, look at creation in Genesis 1 and man was created on the 6th day. 5 is symbolic for the devil, refer to the pentagram which is a 5 pointed star and the symbol of the goat which is the symbol for the devil, not Satan. 3 is symbolic for Jezebel. In the occult everything that is Christian is the opposite. So if God has a trinity then so does the occult. Satan, the Devil and Jezebel. Satan is the King and Jezebel is the Queen. Satan and the Devil share one body with 2 heads. So the fact that Laci was 8 mos. Pregnant with a male child is something else that symbolizes it was the occult. A male and a female are opposites and a pure and a defiled sacrifice are opposites and an infant and an adult are opposites. I could explain the theory behind the opposites because it is far more than what people think it is but the easiest way to explain it here is the yin and the yang. Symbolic for good and evil. Read Jeremiah 7 starting with verse 16, it refers

- to the Queen of heaven, it's talking about Jezebel and I think her name is Isis in Egyptian mythology, but I can't remember for certain. And refer to Revelation 12 verse 9 which in my bible says "This dragon-the ancient serpent called the Devil or Satan..." They are in the same body with 2 heads, a 2 headed dragon.
- 5) Now, Laci was 27 years old, the occult would make that one number $2+7=9$, the due date for the baby was 02/10/03 add those numbers together and get $2+1+3=6$ and Scotts age was 30. You have 9,6,3. The fact that the due date added up to 6 and the child was a male was not an accident either. These numbers represent the trimester stages of pregnancy backwards. My guess is that Laci was killed first, the baby second and it is imperative for them to kill Scott now to complete this cycle. They reverse everything and if you were to to interrupt this by freeing Scott it would ruin the purpose they are seeking.
 - 6) And one last clue that I have seen so far, the time Scott was arrested and the time he was booked. 11:10 time arrested, 00:09 time booked. Take the hour of the time arrested and the minute of the time booked, 11:09 and reverse them, 09:11 and take the minute he was arrest and the hour he was booked, 10:00 and reverse them, 00:10. Put the numbers together 09:11 and 00:10. Take out the zero before the 9 and on zerobefore the 00:10 and put them together, 09:11:0:10 and drop the last zero 09/11/01. The date the twin towers went down.

Okay, those are the clues to the purpose of these killings. It is directly related to the twin towers incident.
