21 1. I Robert Holloway am the owner of and lawfully entitled to possession of the
22 property set forth in this declaration.

23 2. On February 1st, 2008 the FBI along with other unknown officers executed
24 a search warrant on my business establishment known as Road Dog Cycle located at
25 4600 Main Street; Denair, California at as well as my residential address' which are
26 located at 5604 Moberg Road; Turlock, California and 5606 Moberg Road, Turlock,
27 California.

1 3. They left an inventory of some of the property that was taken and I need to
2 have certain items returned because original documents are necessary to effect the sale
3 of certain motorcycles. For example they took a box which was located on or near my
4 desk in my office that contained 30 motorcycle pink slips which have been sold or are
5 available for sale, some of which are in the process of being shipped to Europe and
6 original pink slips are necessary in order to clear the bikes through US Customs.
7 Additionally, some of the motorcycles are on consignment and have either been sold or
8 are in the process of being sold and thus the original pink slips are necessary to transfer
9 title to the new owners.

10 4. Additionally, during the search 30 to 40 - 5" X 7" Receipt Books as well as a
11 box of hand written notes for loans and payments were taken from my office that evidence
12 the sale on credit of a number of motorcycles. These are the only documents that
13 evidence what the original sale price was and the number of payments that have been
14 made by my customers and thus I need those documents back to continue collecting
15 payments and crediting my customers as they should be.

16 5. There were additionally, several checks that were in the bank deposit bags
17 that were taken when the agents searched my briefcase, one of which was for seven
18 thousand dollars (\$7,000.00) and the others for lesser amounts. As well as ten thousand
19 dollars (\$10,000.00) in cash which was taken from my safe at my residence and
20 approximately seventeen hundred dollars (\$1,700.00) in a metal cash box and six hundred
21 and sixty dollars (\$660.00) which was money from a high school class reunion which I was
22 involved with.

23 6. I would request that the court order all of the items listed above be returned
24 to me as I am entitled to lawful possession of the property.
