 <p><b>Alfred Lowell "Chip" Huskey, 47, of Modesto</b> Adult stepdaughter told authorities Huskey smoked marijuana and had sex with her when she was a girl, adding that he molested her from age 3 to 11; in a taped phone call, Huskey acknowledged sex but not continuous abuse. <b>Sentence Date: May 11</b></p>	Lewd and lascivious act with a child	Pleaded no contest to unlawful sex with a minor	1 year jail	No
 <p><b>Michael Anthony Garcia, 34, of Modesto</b> A 15-year-old victim told authorities Garcia molested her since she was 8 years old. <b>Sentence Date: May 4</b></p>	Continuous sexual abuse of a child	No contest plea	6 years prison	Yes
 <p><b>Timothy Ryan Jamison, 48, of Modesto</b> A Modesto mother spotted Jamison fondling her 4-year-old son; authorities found pornography involving children and sexual aids in the shed of a Salida church where Jamison played the organ. <b>Sentence Date: April 28</b></p>	Lewd and lascivious act with a child, possession of obscene matter	Pleaded no contest to both counts	3 years, 8 months prison	Yes
 <p><b>William Wendell Fritz Jr., 55, of Ceres</b> A tip led authorities to five videotapes that showed numerous sex acts between Fritz and two children: a 10-year-old girl and a 7-year-old boy. <b>Sentence Date: April 20</b></p>	11 counts of committing a lewd and lascivious act with a child under 14, three counts of using an underage person for obscene matter, two counts of sexual penetration of a child under 14, continuous sexual abuse of a child and oral copulation of a child under 14	Pleaded guilty to three counts of committing a lewd act upon a child	45 years to life in prison	Yes
 <p><b>Ronnie Carlton Rogers, 25, of Modesto</b> Victims who were under 14 told authorities about inappropriate touching and sexual acts from 2001 to 2008. <b>Sentence Date: March 24</b></p>	Three counts of committing a lewd and lascivious act with a child under 14, continuous sexual abuse of a child, dissuading a witness through threat or force	Pleaded no contest to one count of committing a lewd and lascivious act with a child and the continuous sexual abuse of a child	22 years prison	Yes
 <p><b>Ramiro Raya, 20, of Empire</b> Visited a family friend one night when he was drunk, touched a 9-year-old inappropriately while her mother was in the shower. <b>Conviction Date: March 13</b></p>	One count of committing a lewd and lascivious act with a child under 14	Convicted at trial	Sentence pending	Likely
 <p><b>Bernard Enarson, 40, of Modesto</b> Parents obtained a restraining order to keep Enarson away from their 13-year-old daughter; he was arrested after the girl ran away and was found in Enarson's home. <b>Sentence Date: March 9</b></p>	Lewd and lascivious act with a child, unlawful sexual intercourse with a minor, two counts of oral copulation with a child	Pleaded no contest to committing a lewd and lascivious act with a child	3 years prison	Yes
 <p><b>Jerry Franklin Johnson, 57, of Riverbank</b> A 7-year-old girl reported molestation by Johnson in 2008; an investigation led to prior incidents involving three other young girls since 1992. The victims attended an Oakdale church where Johnson was a member. <b>Sentence Date: March 4</b></p>	Four counts of committing a lewd and lascivious act with a child, possession of child pornography	Pleaded no contest to three counts of committing a lewd and lascivious act on a child	10 years prison	Yes
 <p><b>Billy Morris, 49, of Modesto</b> Touched an 11-year-old girl's breast while using drugs with other adults in her home in 1996; incident reported years later. <b>Sentence Date: Feb. 26</b></p>	One count, lewd and lascivious act with a child	Guilty plea	3 years prison	Yes
 <p><b>Jesse William Emmett, 26, of Modesto</b> An 8-year-old told authorities that Emmett would make him orally copulate him when they were alone. <b>Sentence Date: Jan. 29</b></p>	Three counts oral copulation with a child, lewd and lascivious act with a child, attempting to dissuade a witness	Pleaded no contest to one count of oral copulation with a child	3 years prison	Yes
 <p><b>Eric Albarico, 32, of Modesto</b> A 13-year-old who was related to Albarico's girlfriend reported months of molestation while she lived in his home. <b>Sentence Date: Jan. 13</b></p>	Two counts of lewd and lascivious acts with a child, oral copulation with a child, sexual penetration of a child	Convicted of all counts by a jury	6 years prison	Yes
