Fiscal Year 2010 Budgetary Impacts to  
 Department of Parks and Recreation Programs, Services and Facilities  
 Effective July 6

**Sacramento, California, June 29, 2009**—Due to the budget cuts contained in the Department of Parks and Recreation’s Fiscal Year 2009-2010 budget adopted by the City Council, the Department is implementing on July 6 specific reductions to its programs, services and facility operations. Below is a list of the major reductions and cuts that immediately affect the public for the City’s Community Centers, Swimming Pools, Recreation Programs and Park Maintenance Services. ## ***Recreational Programs:***

Summer Clubs and Day Camps will not operate at the following locations: American River Village Apartments, Burberry Park, Colonial Park, Didion School/Club House, Gardenland Park, Bertha Henschel Park, Marina Vista Housing Complex, North Laguna Creek Park, Parkway Oaks Park, Renfree Park, Southside Park, Taylor School and Tahoe Park.

***Park Maintenance Operations:***

Regular park maintenance will be provided at the City's 215 parks and other park areas every two to three days rather than every day as currently provided. Grass will be mowed at each park every 10 to 12 days rather than every 7 days as currently provided. Bathrooms in all parks will be closed with very minor exceptions. Bathrooms at McKinley Park and William Land Park will remain open because they are the only parks with maintenance crews that work exclusively at the park. Bathrooms may also be open during large events operating under a special permit where the permit holder pays an additional fee to cover the cost of staffing.
