This is the StanCERA retiree payroll data for the retiree payroll paid on August 3, 2009 for the month of July 2009. These figures represent one month's payments. The accumulated cost of living adjustments (maximum 3% per year) are being paid pursuant to Government code section 31870.1 as adopted by the Stanislaus County Board of Supervisors on June 24, 1969. On July 8, 2009 The StanCERA Retirement Board voted to suspend the revocable health benefits subsidy paid in accordance with Government Code section 31691.1 (and revoked in accordance with Government Code section 31692) for calendar year 2010. The revocable health benefits subsidy amount will therefore not be paid beginning with the January 4, 2010 retiree payroll. Amounts of members' allowances which have been divided upon a court's domestic relations order, have been re-combined to show the members' full retirement allowance.
